Location

Unit 1, Riverside Workshops is situated on the established Riverside Industrial Estate which is conveniently located less than 1 mile from Seaton Town Centre and close to amenities.

Description

Unit 1 is an end of terrace in a block of 4 similar units measuring approximately 589 sq ft (54.72 sq m) GIA.

The unit benefits from a WC and separate hand-wash basin, concrete floor (due to be redecorated before Lease Commencement), a single door and a set of double doors, all to the front of the Unit. To the rear of the Unit there is a fire door (also due to be replaced before Lease Commencement).

Lease Terms

The Unit is offered by way of a new internal repairing and insuring lease for a 6-year term with a rent review at year 3. The lessee will have the option to terminate the lease at any time, upon serving the Council at least 3 months' notice in writing. The landlord will be able to determine upon serving the lessee 6 months' notice in writing.

The lease will be contracted outside of the Security of tenure provisions of the Landlord & Tenant Act 1954.

The site is being marketed with a guide rent of £6,000.00 per annum, exclusive of outgoings.
